Who We Are

The Ukraine War Archive (UWA) is a UK-registered non-profit (Company No. 16044305) operating a digital platform that collects, preserves, and shares evidence of international crimes and human rights violations stemming from the war in Ukraine.

What Information We Collect

- **Personal Data (Direct/Indirect):** Names, contact details, access logs, IP addresses, and metadata linked to users' interaction with materials.
- Verification Data: Information submitted through the Access Request form to establish user credentials and affiliation.
- **Platform Usage Data:** Metadata on access attempts, downloads, and viewing behaviors (in compliance with audit trail requirements).
- **Special Category Data:** May be encountered through evidence materials, handled under strict access control and with legal basis under Art. 9 GDPR and equivalent Ukrainian legislation.

How We Use Your Information

- To verify, authorize, and assign Access Levels.
- To ensure platform security, data integrity, and legal compliance.
- To support legal, educational, and historical research within a controlled environment.
- To fulfill legal obligations (e.g., under Binding Legal Requests).

Legal Basis for Processing

- Legitimate Interests: In preserving historical and evidentiary records and facilitating justice.
- **Consent**: Where users voluntarily provide information via forms or contact the Archive.
- Legal Obligation: Compliance with UK GDPR, EU GDPR, and Ukrainian Law.

Data Sharing

- UWA does not sell or commercially exploit personal data.
- Data may be shared with international courts or legal bodies under secure protocols and subject to chain of custody compliance.
- In urgent or legally compelled scenarios (e.g. court orders), UWA may disclose material per Clause 3.8 of the Contributor Agreement .

- Processing activities may be supported by authorised data processors acting under written agreements that ensure compliance with applicable data protection laws, including Infoscope Ltd. as the platform infrastructure partner.
- We implement technical and organisational measures to protect personal data against unauthorised access, accidental loss, destruction, or alteration

Data Transfers

• Transfers to the UK, EU, and other jurisdictions are governed by Standard Contractual Clauses (SCCs) or equivalent mechanisms .

Data Retention

- Retained as long as necessary for evidentiary, archival, or public interest research purposes.
- Anonymisation/pseudonymisation applies where possible to minimize privacy impact.

Your Rights

You may:

- Request access to your personal data.
- Request erasure or restriction (subject to legal limitations).
- Object to processing.
- File a complaint with the UK ICO or your local supervisory authority.
